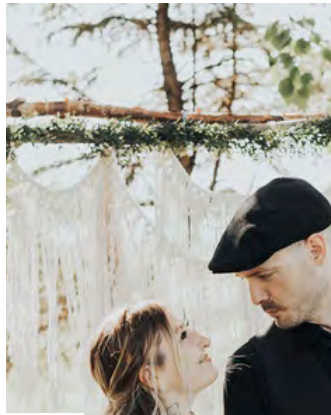

Chalet Rental Agreement

Please read and complete this rental agreement and return it to Sunridge Ski Area with your confirmation deposit of \$1,000. In this agreement, the "**Facilities**" include the chalet (and contents), ski lifts, ski hills, surrounding parking lot and all property thereon. The "**Rentee**" includes all employees, members, and guests in and using the Facilities during the rental.

1. The Facilities rental shall be paid in full prior to or on the day of the booking. Payment must be by VISA, Mastercard, INTERAC, cash, or certified cheque. Personal cheques are not accepted. The confirmation deposit is non-refundable and is forfeited if your booking is canceled
2. A damage deposit of \$2,000 (VISA or Mastercard) must be paid in full prior to the occupation of the Facilities. Defacing or willful damage or theft of any property will be the responsibility of the Rentee who shall bear all costs arising from such damage or disappearance. Any damage or cleanup costs more than the damage deposit will be charged to the credit card on file. You will be notified prior to any damage charges.
3. Any decorations which are set up must be taken down on the night of the function. No staples or tacks are to be used for decorating. Any materials affixed to the walls, floors, ceilings or furnishing must use green painters tape only. Duct tape is not permitted. **Candles, confetti, balloons, sparklers, glitter, and fog/smoke machines are NOT PERMITTED. Your damage deposit will be forfeit if such items are used.**
4. All properties of the Rentee and guests in the Facilities are at the sole and exclusive risk of the Rentee and in no way will Calido Recreation be liable for loss or damage to said property.
5. **The Rentee agrees that during occupancy and use of the Facilities, the Rentee will WAIVE ANY AND ALL CLAIMS that the Rentee has or may have in the future against Calido Recreation Management Inc.(dba Sunridge Ski Area) and their directors, officers, employees, guides and representatives (all of whom are hereinafter referred to as "the Releasees"). The Rentee also agrees to RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that the Rentee may suffer, or that my next of kin may suffer as a result of my use of the facilities, due to any cause whatsoever. The Rentee also agrees to HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third party resulting from the use of or presence in the premises.**
6. If alcohol is served, the Rentee is responsible for obtaining a liquor permit. The Rentee is responsible for the conduct of guests, as well as ensuring that guests abide by liquor board regulations. Bartenders will not serve guests who are obviously intoxicated. The liquor license covers the chalet only and drinking is not permitted on the grounds or in the parking lots. The bar is open from 4pm to midnight. The chalet closes at 1am.
